### Announcement of organizational reforms, executive reshuffle, and other personnel changes

Mandom Corporation announces that it will introduce the following organizational reforms, and carry out executive reshuffle and other personnel changes.

1. Strengthening group management execution structure and organizational reforms (April 1)

#### (1) Introduction of CxO system to strengthen group management execution structure

Starting with the 12th middle-range management plan, we have transitioned to a matrix structure based on the business and functional axes in an effort to strengthen group synergies. On April 1, 2024, the first year of the last middle-range management plan (14th middle-range management plan) ahead of VISION2027, we will introduce a CxO system to further strengthen our matrix system. The business CxO will be responsible for the entire operations in Japan, Indonesia, and overseas, while the functional CxOs will be responsible for their assigned area across the group from a group management perspective. Through this arrangement, we aim to strengthen the group management execution structure, optimize the allocation of management resources, speed up decision-making, accelerate innovation and increase growth potential.

#### (2) Introduction of Executive Fellow

We will introduce the position of "Executive Fellow" as the highest rank for professionals with highly specialized knowledge and outstanding achievements. This is aimed at having our professionals make a broader contribution, including leveraging their expertise to negotiate with external specialized organizations, building relationships, providing guidance to and train junior staff, and making recommendations to the management using their specialized knowledge.

#### (3) Organizational reforms

① Brand Marketing Div. 1 and Brand Marketing Div. 2 will be changed to product development functional divisions and respectively renamed to Product Marketing Div. 1 and Product Marketing Div. 2. Their respective communication functions will be transferred to a Communication Marketing Div. to be created. We will strengthen these divisions by making them focused more on promoting brand marketing.

#### ② Abolition of International Marketing Div.

We will transfer the product development function of the International Marketing Div. to Product Marketing Div. 1 and Product Marketing Div. 2., and its communication function to the Communication Marketing Div. to strengthen brand marketing of the group.

#### 3 Marketing Strategy Div. to be renamed Global Brand Strategy Div.

The division will promote brand management globally and strengthen the group's marketing and brand strategies.

#### 4 EC Marketing Div. to be renamed BX Promotion Div.

The division will strengthen the development and promotion of new business models, focusing on EC and D2C businesses.

## (5) Package Development Div. to be set up

We will establish Package Development Div. to create value by enhancing functions (appearance, usability, functionality, environmental friendliness, etc.) of product packaging that is required in an ever-changing environment.
