Announcement of organizational reforms, executive reshuffle, and other personnel changes

Mandom Corporation announces that it will introduce the following organizational reforms and carry out executive reshuffle and other personnel changes.

1. Organizational Restructuring (as of April 1)

(1) Establishment of "Chief Risk Officer (CRO)" and "Risk Management Division"

Recognizing that building a robust governance system is a critical issue in promoting group management, we will establish a "Chief Risk Officer (CRO)" responsible for the Risk Management domain. This initiative is aimed at maximizing corporate value and strengthening the governance system of the group.

"CRO" will oversee "Risk Management Div. ", "Legal Affairs Div.," and "Quality Assurance Div." as part of the Risk Management domain. They will work to enhance governance and compliance across the Mandom Group from both a business and functional axis.

(2) <u>Renaming "Chief Operating Officer (COO) of International businesses" to "Chief Operating Officer (COO)</u> of Northeast Asia, Southeast Asia, and India Business," with partial role transfer to "Chief Strategy Officer (CSO) "

The current "COO of International Businesses" has been responsible for both existing and new markets outside of Indonesia. To further expand the scale of operations and strengthen new market development in overseas businesses, responsibilities will be restructured: "COO of Northeast Asia, Southeast Asia, and India Business" will focus on existing markets.

"CSO" will take on responsibility for new markets. This restructuring aims to create a system that enables more efficient utilization of management resources and ensures swift and unified decision-making.

(3) Organizational reforms

① <u>"Global Brand Strategy Div." and "Communication Marketing Div." will be reorganized into the "Marketing Strategy Div." and "Brand Communication Div." respectively.</u>

The brand management function of the "Global Brand Strategy Div." will be merged with the existing functions of the "Communication Marketing Div." to form the "Brand Communication Div." This reorganization aims to maximize the brand value of globally deployed product brands and strengthen communication strategies.

②<u>Renaming "Purchasing Div." to "Strategic Procurement Div." and transferring it to the Corporate Planning</u> <u>domain</u> "Purchasing Div." will be renamed "Strategic Procurement Div." and transferred to the corporate planning domain. This division will expand global procurement across the group, building an efficient procurement system in collaboration with various business and functional units.

③ Establishment of "Risk Management Div."

A new "Risk Management Div." will be established to lead the group in strengthening its risk management and governance systems under the Risk Management domain.

(4) <u>Renaming "International Business Div." to "Northeast Asia, Southeast Asia, and India Business Div.</u> (hereinafter 'NSI Business Div.')" and abolishing "International Business Strategy Div." with function transfers to "NSI Business Div." and "Corporate Planning Div."

The "International Business Div." will be renamed "NSI Business Div.," while the "International Business Strategy Div". will be abolished. Strategic planning functions of the "International Business Strategy Div." will be transferred to the "NSI Business Div.," and new market development functions will be transferred to the "Corporate Planning Div."

This restructuring will allow the "NSI Business Div." to focus on expanding the scale of existing markets, while the "Corporate Planning Div." will build a system that aligns business strategies with new market development initiatives.
